## PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF WELLS COUNTY, ND May 5, 2020

NOTE: All Motions unanimously passed unless otherwise stated.

KEY: M-Motion; MS-Motion Second; VV – Voice Vote; MC-Motion Carried.

The Board of County Commissioners met in regular session with the following members present: Dennis T. Dockter, Chairman; Mary Hager, Danny (Boone) Maxwell; Stan Buxa and Leon Klocke.

Also present was Neil Thormodsgaard.

Chairman Dockter called the meeting to order.

M was made by Commissioner Hager and MS by Commissioner Buxa to dispense with the reading of the minutes of the previous meeting minutes and that they be approved and published in the official newspaper of Wells County, The Herald-Press.

UPON VV, MC

Timesheets were reviewed.

The Middle Upper Sheyenne Water Project was discussed.

M was made by Commissioner Buxa and MS by Commissioner Klocke to approve the bills.

UPON VV, MC

Portfolio Reports.

M was made by Commissioner Klocke, MS by Commissioner Maxwell, to remove the prior Motion from the April 7, 2020 meeting, regarding the repair of the sidewalk and adding two other pads for picnic tables.

UPON VV, MC

M was made by Commissioner Klocke, MS by Commissioner Hager to advertise for bids for the repair/replacement of the sidewalk on the east side of the building and to draw up plans for an additional handicap parking space, and a possible pad for the dumpster and picnic tables.

UPON VV, MC

Commissioner Maxwell briefly discussed the Fair Boards decision to cancel the Wells County Fair this year due to the COVID 19 pandemic. The Commissioners discussed the idea of the Board to consider other events at the Fairgrounds throughout the summer.

Correspondence. Chairman Dockter presented a letter from the Federal Dept. of Transportation, as they would like a letter of support for the Hwy 3 & 200 project. The Auditor will send this letter in.

The Auditor let the Commissioners know about the request from the State for County expenses related to COVID 19. NDACO President Terry Traynor asked for expenses from each County so that they could submit them for a possible 100% reimbursement through the CARES Act. Wells County had over \$3,000 in expenses that was submitted.

Janelle Pepple, Wells County 911 Coordinator, stopped in to talk about the 911 fees. The new per line fee will be \$1.36 per line per month. Ms. Pepple also informed the Commissioners that events that have been scheduled for the Festival Hall this summer are still on hold due to COVID 19.

M was made by Commissioner Buxa, MS by Commissioner Hager to accept a contract that was submitted by the ND Office of State Administrator regarding the funding agreement for the Clerk of District Court services. The amount of funding per month will be going down \$198.00 for 2021-22.

UPON VV, MC

The Commissioners reviewed a letter from the Bureau of Land Management asking Wells County to participate in the ND Resource Management Plan. Wells County will not be a cooperator at this time, but would like to receive notification of public meetings and the availability of draft documents for public review and comment.

An application for an Abatement of Taxes for the Homestead Credit for the 2018 and 2019 tax years was reviewed for Parcel #'s 81352000, 81354000, 81353000, 70152000 & 81343000.

M was made by Commissioner Buxa and MS by Commissioner Hager to approve the applications.

UPON VV, MC

An application for Property Tax Exemption of a Farm Residence was reviewed for Parcel #21173000, 1009000 & 100900001. Applications for Abatement or Refund of Taxes for Parcel #60058000 for 2018 & 2019 were also reviewed.

M was made by Commissioner Klocke and MS by Commissioner Hager to approve the applications.

UPON VV, MC

A request from an employee for a time clock was discussed. The Commissioners will look into the matter and the cost for a time clock.

Pay raises for 2021 Budget process were discussed next. The Auditor gave the Commissioners information from the Consumer Price Index, as that is what is generally followed from year to year in pay raises.

M was made by Commissioner Buxa, MS by Commissioner Maxwell to follow the 1.8 % guideline from the CPI for 2021 payroll budgeting purposes, with actual percentage to be determined later.

UPON VV, MC

Brent Keller, Wells County Road Foreman, updated the Commissioners on various things with the Road Department. Updates included the condition of the roads, the JD loader (lender) that will be delivered next week and the Wellsburg Bridge. He also stated that there is no hurry to take off the road restrictions due to the conditions of the roads at this time. The Ford pickup being used by the Road Crew could be put up for bids as it has over 250,000 miles on it.

He has hired one temporary summer person to help out. When Tristin Schimke went from temporary summer help to full time, his wage was never increased, therefore still making the same amount as the temp. hired this summer.

M was made by Commissioner Buxa, MS by Commissioner Maxwell to increase Tristin Schimke's wages by \$1.00, effective May 1, 2020.

UPON VV, MC

Terry Kost of Harvey then came in and talked to the Commissioners about a fencing problem he is having with his Township. General consensus by the Commissioners was that it was out of their hands.

Mary Hager left the meeting.

Tammy Roehrich, Wells County Emergency Manager and Wells County Sheriff Christopher Kluth entered the meeting. Discussion was held on the re-opening of the Courthouse and KTL Building to the public. General consensus was to be closed for another two weeks, then to re-evaluate the situation. Tammy then discussed the possibility of becoming a mass test site for COVID 19 in Wells County.

M was made by Commissioner Buxa, MS by Commissioner Maxwell that if the State were to pick Wells County for mass testing for COVID 19, Wells County will pay for the cost up front from the emergency fund, as the State would reimburse for those costs.

UPON VV, MC

M was made by Commissioner Klocke, MS by Commissioner Buxa to participate in a Run, Hide, Flight training on July 23, 2020, in Wells County. This would be mandatory training for all employees.

UPON VV, MC

Sheriff Kluth and the Commissioners also discussed the possible contract with the City of Fessenden and Wells County for police services. The Sheriff will meet with the Mayor for further negotiations.

The meeting was then recessed to go into Executive Session for discussion of security issues in the Courthouse.

Meeting was re-adjourned.

Randi Suckut, Wells County HR Director met with Commissioners regarding the personnel policy and vacation carryover. In the policy it states that personnel cannot carry over 80 hours of vacation time into the next year. Employees are asking that it be waived for 2021 due to COVID and some having to cancel vacation plans.

M was made by Commissioner Buxa, MS by Commissioner Maxwell to extend the carryover hours from 80 to 100 for 2021 only due to the pandemic. It will be for the one year only. UPON VV, MC

Mr. Suckut then talked about NDPHIT. It is a group that was put together by the Hays Companies, Inc, in cooperation with NDIRF for a public health insurance trust. It could be something that would benefit Wells County in the area of health insurance and other benefits. The Commissioners instructed the Auditor to provide the information to the Hays Companies that they need in order to evaluate our current policy.

Carrie Krause, Wells County Recorder, met with Commissioners regarding her trip to Austin, TX in February to attend the Property Records Industry Association meetings.

Ms. Krause then informed the Commissioners that her office can take payments with a credit card over the phone now.
