## Wells County Commissioner's Meeting Minutes May 4, 2023

The May meeting was called to order by Chairman Buxa at 8:34 AM. Present at the meeting were Dennis Dockter, Leon Klocke, Bryan Lautt, Danny Maxwell, and Daniel Stutlien.

Harvey Dam was requested to be added to the agenda.

Under the consent agenda:

BL (M), DD (S) to approve the minutes from the April Meeting. Unanimously carried.

Employee timesheets were reviewed by the commissioners. There was discussion of the timeliness of timecard submission.

LK (M), DM (S) to approve the bills as presented. Unanimously carried.

DD (M), DM (S) to approve Laura Muscha, Treasurer, and Daniel Stutlien, Auditor, to purchase CD's on behalf of WC. Unanimously carried.

The current WC Balance Sheet was reviewed.

Correspondence was shared from FEMA and the Missouri River Joint Water Board.

Pledged Securities for FIBT accounts were reviewed by the Commission. It was the consensus of the WC Commission the securities were adequate to cover the county's deposits.

At the request of Chairman Buxa, the WC Auditor prepared for the Commission a listing of the CD assets of Wells County. Those details were share and discussed.

Commission Portfolios were reviewed and discussed.

Tammy Roehrich, WC DES, discussed her department with the Commissioners. Specific discussion of FEMA's regulations regarding zoning ordinances was held. In addition, Roehrich requested relief from the Work Schedules and Flex Time Policy (*Policy 502*) adopted last Fall by waiving the policy for her office. BL (*M*), LK (*S*) to approve the request because half the salary is paid by the Fed. Unanimously carried.

Janelle Pepple, WC Sheriff's Dept./911 Manager met with the commission to request a return to a 37.5 hour week. DM (M), BL (S) to approve this request. Unanimously carried.

Brent Keller, WC Road Foreman, met with the Commission to discuss matters of his department. Korey Jensen has been hired by the Road Dept. for Summer help. Keller discussed some of his challenges getting supplies for upcoming work and shared the work the Dept. is presently engaged in.

Dale Schmitz, WC resident in Manfred Township, met with the Commission to discuss runoff water issues near his residence. Schmitz was directed to the Water Board for consideration on how the flow can be controlled in subsequent years, and the consensus of the Commission was to recommend a flow plan for Drain #1.

WC Auditor, Daniel Stutlien, provided an update for ARPA funds received by Wells County. Having just filed a federal report, WC has utilized \$333,739.09 of the \$744,710 allocation. Funds must be utilized by 12/31/24.

Regarding the Cathay School, the WC Auditor informed the Commission all contracted asbestos removal must be completed by 6/2/23 when the contract expires. The building will be razed shortly thereafter.

An annual request from the Bremen Bar for authorization as a gaming site was introduced to the WC Commission. DD (M), DM (S) to approve this request. Unanimously carried.

The next Six-County Meeting will be held in McIntosh County Tuesday, June 13th, at 10:00 AM.

The next WC Departments' Meetings are slated for Thursday, May 25th, at 9:00 AM.

The RFP for preliminary and design engineering for the replacement of three bridges in WC in 2025 netted proposals from Apex of Bismarck, KLJ of Bismarck, and Wold of Bottineau. Interviews will be set for each of the three firms later in May. It was the consensus of the Commission to schedule interviews for Friday, May 12<sup>th</sup>.

A Raffle Permit Request form WC 4H Bremen Friendly Neighbors was considered. DD (M), BL (S) to approve this request. Unanimously carried.

Discussion was held on the ongoing Harvey Dam and Reservoir issues.

The regular June WC Commission meeting will be June 6, 2023 at 8:30 AM. There being no further business, the meeting was adjourned at 11:17 AM.
